


Prof. George A.O. Magoha, EGH




Cabinet Secretary Industrialization, Trade & Enterprise Development

Principal Secretary the National Treasury & Ministry of Planning







Bachelor of Industrial Technology from Egerton University and a Post- Graduate Diploma in Medical Electronics from the University of London.



Deputy Chief Justice/Vice President of the Supreme Court



Judge of the Supreme Court of Kenya


